The federal government does redistribute income to the states, but not in relation to mining projects. A soon-to-be-implemented minerals resource rent tax to be collected by the federal government will be used to deliver general tax breaks and some investment in mining region infrastructure..

As this analysis is WA-focussed, the author is right to point out WA's royalties for regions programme.

"Australia has a complex array of tax and non-tax revenue raising instruments that it applies to the mining industry. Different resource taxes, royalties and payment arrangements are imposed across different resources, and on the same type of resource depending on its location. In relation to petroleum, these include PRRT, crude oil excise, a series of different royalties applied by the Australian government (the offshore petroleum royalty, the internal waters royalty and the resource rent royalty) and different oil and gas royalties applied by the States. Further, mineral resources are subject to different royalty arrangements across the States including ad valorem royalties, specific royalties, profit royalties or a combination of these types of royalties."

At a national level, it is misleading to suggest that any federal or state government in recent times has engaged in deceptive or corrupt practices regarding mining revenues or more general tax distributions. Of course there is perennial sniping between states and federal government regarding distribution of funds, but this is political rather than a transparency issue. Even at a WA state level, it is misleading to suggest that the state government "changed amounts transferred without justification or approval". It has not. Only in relation to some points of the implementation of the RfR programme - hardly the entire use of mining revenues - have some anomalies been found and these are not in relation the state government's practices. Even the auditor general's report doesn't suggest that anything untoward has occurred, concluding "Money was distributed in accordance with the high level objectives and eligibility criteria for the funds and projects we reviewed."

Since 2011, offshore minerals are governed by a common national legislative regime that in Western Australia is given force by the Offshore Minerals Act 2003.




