#### **Comments:**

There is no SWF in Mongolia. A Human Development Fund was created in 2009 but its characteristics are different from a sovereign wealth fund or stabilization fund.

"During the previous election campaign the leading parties made promises to pay every citizen between MNT 1 million and MNT 1.5 million (around US\$ 1,200) from the prospective mining riches. To fund these promises, the 2009 Oyu Tolgoi investment agreement included frontloaded payment of future mining royalties by Ivanhoe Mines, the private investor. These payments were channelled to the specially created Human Development Fund, a general vehicle for redistribution of mining wealth and social spending. By law, the Human Development Fund is financed from mining dividends pertaining to the state and an (unspecified) part of royalty payments to the budget. The funds can be used for cash handouts to all citizens, as well as for payments linked to pensions, health care, education and housing. The law does not contain explicit provisions determining the size of payments from the Fund. The revenues and expenditures of the Fund are approved annually as part of the general budget process. In addition, Article 8 of the law contains a somewhat vague indication that every Mongolian may hold non-tradable preference shares in a state-owned legal entity, which holds strategic mining licences. The law leaves open to interpretation the exact relationship between such a

holding and the Human Development Fund. As of the end of 2011, the undisbursed portion of the preelectoral promise (net of the payments made in 2010 and 2011) amounted to around 25 per cent of the projected 2012

- 3) Article 5.1 of the Minerals Law of Mongolia states "mineral resources naturally occurring on and under the earth's surface and in natural water courses in Mongolia are the property of the State".
- 4) Therefore, 'the State, as owner of all mineral resources in Mongolia, has the right to grant exploration and mining licenses to other persons in accordance with the terms and conditions of this law' (article 5.1 of the Minerals Law of Mongolia).

## 1.1.002: Who has authority to grant hydrocarbon and mineral rights or licenses?

For exploration and mining of uranium products, Nuclear Energy Authority has the authority to issue licenses, according to Law on Nuclear Energy, Argicle 11.6.5.

But for oil exploration and exploitation, Ministry of Mineral Resources and Energy issues the licenses, in compliance with Law on Oil, Article 4.1. Given oil is not a prominent sector compared to mining, one can go with answer B.

#### **Comments:**

General Licensing process is well explained on the government's website. The Minerals Law regulates the process of issuing and canceling special licenses. And they are published in public media such as newspaper.

If the question is related to the stability agreements or investment agreements for the strategically important mines (which are defined in the Parliament Decree No.27), the answer would be mixed. There had been at least 5 stability agreements signed as a result of negotiation between the government and mining companies in the past, very little is known in terms of its process. The only exception was the Oyu Tolgoi investment agreement, which is the largest copper and gold project in the country.

There have been 3 stability agreements signed by the government in the past, and all three were published on the Ministry of Finance website \http://www.mof.gov.mn/search?lan=mn&c=139798\ since that ministry was in charge of signing such agreement prior to 2006. One investment agreement was signed, Oyu Tolgoi, which is a public document. However, the government has not published a shareholder agreement on Oyu Tolgoi, and also service agreement on Tavan Tolgoi coal mine. Also, in oil sector, Production Sharing Agreements are concluded with more than a dozen companies, and none of the contracts are public.

## 1.2.008.b: Are environmental impact assessments for oil, gas and mining projects published by the authority in charge of regulating the sector and is there a consultation process?

#### **Comments:**

Environment impact assessments (EIA) and Detailed Environment impact assessments (DEIA) are

required to be developed under the law of environmental impact assessment prior to mining any minerals. These documents are submitted to the Ministry of Nature and Environment (MNE) for review and approval. Depending on the type and complexity of the projects, the MNE may approve, reject the project, or ask for a DEIA.

When submitting a DEIA, the applicant must include an official documentation from the Local Citizens Assembly of the administrative unit, where the project is to be implemented. The company will have introduced its project and expected activities to the local government and members if the citizens Assembly, and obtain their approval.

In terms of publishing the data, there is a government website where all the approved the EIAs are stored and are available for viewing. But, very little information would be available prior to the approval.

It is very hard to provide a definite answer to this question given the current choices. It can only be answered partly.



The Article 5.5 notes that the state may own up to 34% of the shares of an investment to be made by a special license holder in a strategically important mineral deposit, where proven reserves were determined through private financing. For instance, the government of Mongolia owns 34% of the Oyu Tolgoi Copper Project which is being implemented by Rio Tinto.
