If the application for a mining right complies with the statutory requirements, then the Regional Manager must notify the applicant to notify and consult with interested and affected parties within 180 days from the date of notice. It is not specified how this must be reported. Once the applicant is a holder of a mining right or mining permit, then an annual report on the social and labour plan must be submitted.

## **Peer Review Comments:**

In the South African case, the requirement for a social and labour plan to be submitted on application for a mining right in terms of MPRDA regulation 42(1)(a) may be interpreted as qualifying for a positive score in the RWI index for the requirement of a social impact assessment. This is because the objective of the social and labour plan, to 'ensure that holders of mining rights contribute towards the socioeconomic development of the areas in which they are operating' [regulation 41(c)] is in line with international standards relating to social impact assessments.

## **Peer Review Comments:**

The Promotion of Access to Information Act (PAIA) has been used by civil society groups to gain access to information on mining, however, the DMR regularly flouts the law by not responding to requests for information. This needs to be reflected in the survey somehow, as there is an intense debate about access to information in SA currently, with the general trend towards less transparency by government.

Refer to the Mining Weekly 9 March 2012, which quotes Acting Head of the University of the Witwatersrand Centre for Applied Legal Studies, Lisa Chamberlain, who said that between 1 August 2010 and 31 July 2011, of 30 requests for information submitted to DMR, half received no response at all, which constitutes a refusal under the Act. The DMR also 'regularly made use of irrelevant standardised letters' and 'in very few cases were records actually provided'.

The PC does not play any oversight role with regard to the awarding of individual mining licenses as it is seen as an executive function of the department. Only the statistics on a national level are made known and only if the PC asks for it."


